Information on the Procedure of Admission to Studies
in the Doctoral Degree Programmes
at the Prague University of Economics and Business

for academic year 2026/2027

Study programmes

Doctoral study at the Prague University of Economics and Business may be taken in the following programmes:

at the Faculty of Finance and Accounting (FFA)

- **Finance**
- **Accountancy and Financial Management**

at the Faculty of International Relations (FIR)

- **International Economic Relations**
- **International and Diplomatic Studies**

at the Faculty of Business Administration (FBA)

- **Management and Managerial Economics**

at the Faculty of Informatics and Statistics (FIS)

- **Applied Informatics**
- **Econometrics and Operations Research**
- **Statistics**

at the Faculty of Management (FM)

- **Management**

The standard length of study is **4 academic years**; maximum time allowed is 5 years.

The relevant governing legislation: Act No. 111/1998 Sb., on higher education institutions and on amendments and supplements to some other acts (the Higher Education Act), amended and consolidated.

Admission requirements for foreign students

Admission to a doctoral study programme is conditional upon the **proper completion of studies in any branch of master's study programme**. A master's diploma issued abroad must be assessed whether it meets the legal condition for admission to studies (see Request for recognition of education abroad for the purpose of the admission procedure at VSE Prague: <https://www.vse.cz/english/study-at-vse/assessing-foreign-education-in-the-admissions-process/>).

Admission to study is also conditional upon:

- successfully submitting the application with the appendix, including all the necessary enclosures,
- paying the admission fee,
- passing the entrance examination.

The final decision concerning the admission of an applicant rests with the dean of the faculty of the respective doctoral programme with due consideration given to success in the entrance examination, as well as the teaching capacity of the faculty. If an applicant has not been admitted only because of the insufficient teaching capacity at the faculty, the examination results remain valid for one year following the date on which the examination was taken.

Students wishing to study in a programme in a language other than Czech ("**Foreign language programme**") must pay a tuition fee. This fee is € 500 per year. If foreign students study in the combined mode of study (distance form) they come for consultations at a time agreed with their supervisors, but are not always obliged to attend lectures and seminars daily. Nevertheless, they must come to sit the exams. Students can study, sit examinations, as well as write and defend their doctoral thesis, in a foreign language.

Students in the study programmes in Czech ("**the Czech language programme**") do not pay tuition fees. If they study in a full-time mode of study (present form), they can be granted a scholarship during the period that does not exceed the standard length of study. The dean of the faculty will set the amount to be awarded for the scholarship.

Students can apply for residential accommodation (subject to the capacity of the dormitories). For more information see: <https://accommodation.vse.cz/>

Also, those students who have been granted a scholarship by the Czech government do not pay fees and can receive residential accommodation.

Admission procedure

The admission procedure begins upon the receipt of an application submitted by an applicant in electronic form.

The required enclosures:

- a) **a short curriculum vitae and a list of publications** with a short annotation and, possibly, an expert's reference attached (the Faculty of Finance and Accounting, the Faculty of Business Administration and the Faculty of Informatics and Statistics do not require neither annotation, nor reference)
- b) [the Appendix to the Application Form](#)

c) **a document certifying the level of the applicant's academic attainment:**

- Applicants whose previous studies were undertaken abroad need **diploma assessment** (see <https://www.vse.cz/english/study-at-vse/assessing-foreign-education-in-the-admissions-process/>) or a **nostrification** (see <https://www.vse.cz/english/about-vse/information-and-regulations/further-regulations/recognition-of-the-previous-foreign-university-degree/>) that must be completed by the date of the release of the admission decision. The documents necessary for these are **an officially certified copy of the diploma, an officially certified copy of the diploma supplement, and an official translation of these documents** into Czech or English if necessary.
- Graduates of master's programmes provided by Czech universities submit a **digitally signed version or a certified conversion of their diploma** (see <https://ci.vse.cz/english/support/procedures/conversion-of-documents/conversion-to-electronic-format/>).
- Graduates of master's programmes at VŠE are not required to submit their diploma.

d) applicant's intended **thesis of their doctoral dissertation** ([list of topics available HERE](#)) according to the requirements of a relevant faculty as follows:

Faculty	Requirements
Faculty of Finance and Accounting	The Faculty requires a scientific essay (according to the program to which the applicant is applying) on a selected topic in the field of finance or accounting and financial management of a company, approximately 10 pages in length. Applicants choose from approved dissertation topics in Czech or English for their admission essay. The scientific essay contains an analysis of the relevant topic, i.e., a definition of the problem and the current state of knowledge and knowledge gaps in the given field, an overview of research methods, and relevant domestic and international literature. The submitted scientific essay should also include an idea of the focus, objectives, methodology, and structure of the doctoral dissertation. Applicants are advised to consult the focus of the scientific essay and dissertation with the supervisors of the relevant programs in advance. Applicants shall also send their CV, list of publications, and scientific essay electronically to the email address of the study officer for research and doctoral studies at the Faculty. Applicants are required to include in their application the name of their proposed future supervisor with whom they have discussed their application for doctoral study. Applicants must also provide the study advisor with an electronic version of their thesis by email before the entrance exam, the date of which will be announced on the faculty website.
Faculty of International Relations	A research project proposal of about five A4 pages in English. The topic must be presented in the theoretical framework of the chosen programme. Students must specify the aim of the dissertation, structure and its benefit for the programme. The list of literature studied in the appropriate topic must be enclosed. The applicants have to consult the focus of the scientific essay and dissertation with senior lecturers or professors teaching in the relevant programme. The professor's name must be submitted.

Faculty of Business Administration	A research project proposal of approx. 5 pages in the English language. The proposal contains a description of international scientific knowledge concerning the given topic that raises an interesting research question, answer to which would be considered as a contribution. The proposal also contains the aim of the dissertation and proposed methods for its accomplishment. The list of main academic articles from leading international journals that the intended scientific essay is based on must be enclosed. In the application form, the applicants are obliged to fill in the name of a potential thesis supervisor who has confirmed their willingness to supervise the dissertation. This confirmation is an obligatory requirement for taking the entrance examination.
Faculty of Informatics and Statistics	1. For the programme Applied Informatics: a research project proposal, with length approx. 5 pages in English which conforms to the following structure: - definition of the field, - topical theoretical and practical questions related to the chosen field, with the reference to literature (see the next point) - a list of the relevant literature, including a list of institutions and researchers working in the chosen field if needed, - the applicant's own skills in the field (Master's thesis, publications, practice), - definition of the thesis' objectives, - a concept of methods used in achieving the objectives. It is necessary to gain a supervisor's approval of supervision. 2. For the programme Econometrics and Operations Research and Statistics: submission of an intended research project proposal (1-2 pages in English).
Faculty of Management	A research project proposal (4-6 A4 pages) in a form of an academic essay should be submitted with the application. The essay should follow the structure of a research article (esp. the first three sections; that is Introduction, Theoretical Background, Data and Methods). The essay should explicitly state the research aim and the expected contribution to the Management field. The list of literature should be also included. The candidate should indicate the name of potential supervisor with whom they have (optimally) consulted the research aim and the dissertation topic.

Application deadline: 31 May 2026.

For applicants of Faculty of Business Administration – If a candidate completes their master's studies after the admission procedure, but before the date of enrolment into the doctoral programme, they may participate in the admission procedure to the doctoral programme based on

the decision of the Vice-Dean for Research and Doctoral Studies. In the event of successful completion of the admission procedure, the candidate will receive an appropriate notification with a deadline for the submission of a certified copy of their diploma. After this deadline, the admission requirements will be verified again and a decision will be issued to the candidate.

Other dates of admission:

- The Faculty of Informatics and Statistics has a second round of accepting applications during summer with deadline on 31 August 2026.
- At the Faculty of Business Administration and the Faculty of Informatics and Statistics, there is also an additional round of admissions in the fall for programmes starting in the summer semester; in this case, the deadline for applications is announced on the faculty websites.
- There may also be an extraordinary deadline for applicants for governmental scholarship in the first quarter or the year for programmes starting in October of the given year.

Admission fees

The admission fee is **50 €**.

The admission fee is to be paid on-line with a card or it can be paid by a bank transfer or postal order using the details shown in the application form. No other payment methods are available. The applicant assumes full responsibility for paying all bank charges associated with the payment.

The admission fee is not refundable, not even in the event of the applicant not sitting for the exams. The admission fee is also not refunded if recognition of diploma is rejected.

If all the requested papers are provided in order, and on time, and the admission fee is paid, the applicant will receive a letter of invitation to come to take the exams.

Entrance examination requirements

Information is provided by the doctoral study coordinators at the appropriate faculties.

The entrance examinations take place on **16 June 2026**.

In justified cases, it is possible to request and attend the entrance examination on an alternative date that will take place on **10 September 2026**. The alternative date is also meant for students who graduate after the deadline for applications (in case of the Faculty of Finance and Accounting for students who graduate later than June 2026). The alternative date of the examination is not meant as a make-up examination.

At the Faculty of Business Administration, there is no alternative entrance exams date, but there is a second admission period in the autumn of the same year.

In case of winter admission period for the Faculty of Informatics and Statistics, the entrance exams take place in January/February.

Applicants for governmental scholarship shall take the entrance exam on an extraordinary date in February/March. Detailed information will be given in a letter of invitation.

Entrance examinations take place at the address given in the invitations that will be sent to applicants.

In justified cases, it is possible to request sitting the entrance exam via video call; in this case it is necessary to apply to the Dean of the faculty via study coordinator in advance.

Immediately before an applicant takes the examination, they will have to:

- prove their identity and nationality (by an identity card or a passport)
- submit any other missing documents as stated in the invitation to sit the entrance examination

The entrance examination is to be taken in:

- 1) the major specialization
- 2) foreign language (applicable for the Faculty of International Relations).

1) The major specialization subjects' examination takes the form of a discourse on the issues related to the study programme which the applicant intends to study. The assessment of the applicant's performance takes account of the applicant's interest in the field of study, their acquaintance with the issues in that study programme, as well as their general level of knowledge. The discourse presupposes knowledge on the level required for the master's comprehensive final examination in the major specialisation at the Prague University of Economics and Business. Information on the examination as well as the list of literature expected to have been studied can be obtained from the doctoral studies coordinators at the relevant faculty.

2) The foreign language examination

General information

- Reading of a general economics text (15 to 20 lines), summary of the text (in some cases students have to pass a written test)
- Discourse on an issue related to the applicant's major specialization and the topic they intend to focus on.
- Time limit: about 30 minutes.

Special requirements

Faculty	Requirements
Faculty of Finance and Accounting	The faculty does not require applicants to take a foreign language exam. However, the discourse is conducted in English. The Czech language proficiency of foreign applicants for the study programmes held in Czech will be examined during the major specialization subjects' examination.

Faculty of International Relations	All applicants must pass the English entrance exam. Foreigners intending to study in the Czech programme must pass the English exam and written and oral Czech entrance exam. Exemptions in the choice of language examination in the entrance procedure are authorised by the dean of the faculty who can give permission on the grounds of a written request.
Faculty of Business Administration	Applicants do not take the English entrance exam; the interview about the dissertation proposal (oral exam) is however led in the English language. Foreigners (does not apply for Slovak applicants) intending to study in the Czech language programme must pass the interview that is led both in English and Czech. Such applicants must be fluent in Czech.
Faculty of Informatics and Statistics	The entrance interview about the major specialization is led in English. For foreigners going to study in the Czech language programme the entrance interview about the major specialization is led both in English and in Czech.
Faculty of Management	Applicants do not take the English entrance exam; the entrance interview is led in English. International candidates (does not apply for Slovakia) applying for the Czech study program must demonstrate active knowledge of the Czech language during the interview. The admission interview can be organized online.

Evaluation of the entrance examination

Each part of the entrance examination (the major specialization subjects' examination and the examinations in the foreign languages) is graded as follows:

1 - Excellent, 2 - Very good, 3 - Good, 4 – Fail, or students are assessed verbally.

If an applicant fails one of these examinations, they will fail the entrance examination as a whole. The examination board will record the grade plus a brief justification of the grade awarded.

Applicants are admitted to the doctoral study programme on the basis of their entrance examinations results and the availability of suitable supervisors. The dean's decision will be made available to each applicant in accordance with the Higher Education Act. Applicants entitled to be enrolled in studies will receive confirmation that they will be enrolled in studies including information about the start of their studies, form of study, and the department to which they will belong. The Dean of the faculty has the right to change the mode of study with regard to the needs of the faculty. The applicant becomes a doctoral student on the day of their enrolment.

If an applicant is not admitted only due to the lack of teaching capacity in the study programme, the following year they can apply for admission without sitting the entrance exam. In this case, confirmation of having passed the entrance exam must be attached to the application form. Entrance examination pass is valid for one year.

Applicants that are not admitted may request a review of the decision. The request must be submitted to the body that has issued the decision no later than 30 days from its receipt.

Final provisions

These conditions of admission procedure are valid for study in the doctoral study programmes for academic year 2026/2027.

In exceptional cases, the Dean reserves the right to extend the deadline for submission of applications up until the first date of entrance examination. In this case the applicant will pass the entrance exam on an alternative date in September.

Concluding notes

In every administrative contact with the Prague University of Economics and Business, it is necessary to use the name of the university and the name of the relevant faculty. The applicant's name shall be followed by their contact address.
